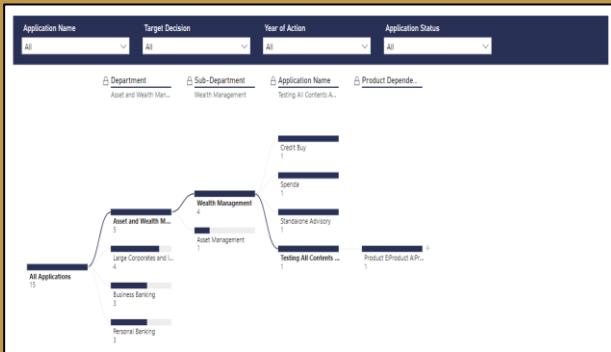

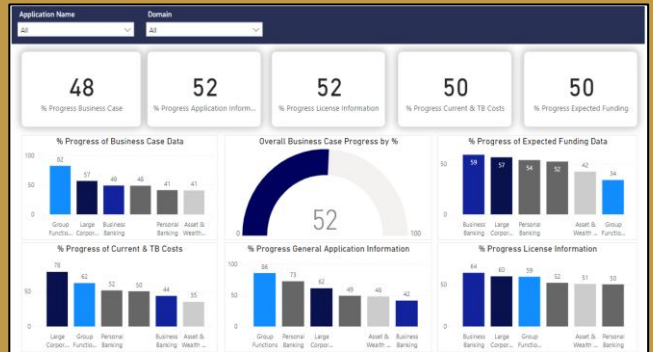

- ✓ We help break down silos and create teams of empowered internal and external subject matter experts when solving complex issues for our clients.



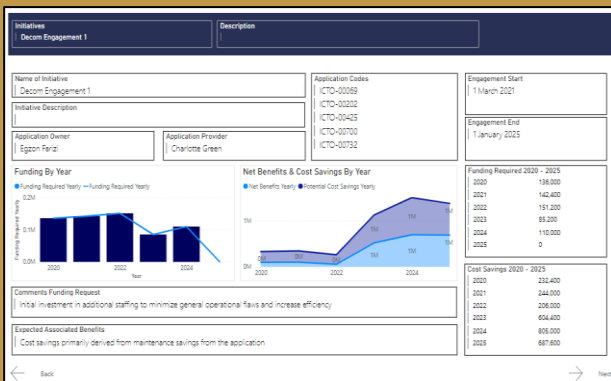

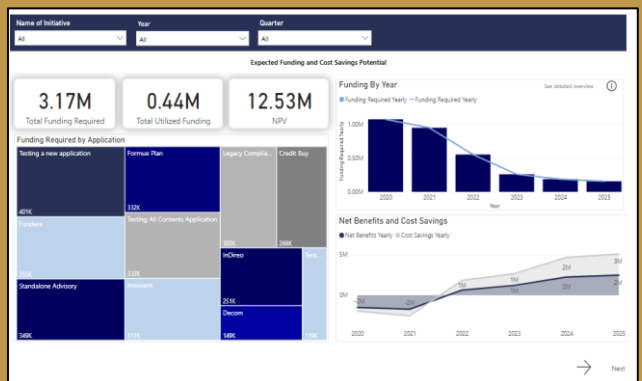

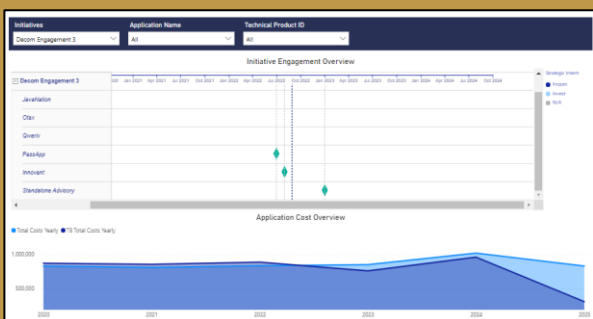
